<p>In Washington, only licensed electrical contractors may perform electrical work. Property owners may apply for an exemption from these requirements by completing this application and signing the affidavit below <b>before</b> beginning electrical work:</p> <ul style="list-style-type: none"> <li>• Complete <b>all</b> sections &amp; mark the applicable fee item(s) on the Fee Worksheet.</li> <li>• After receiving your <b>completed</b> paperwork and payment we will issue a permit valid for 1 year.</li> <li>• Permits can also be purchased online at <a href="http://www.ElecInspect.Lni.wa.gov">www.ElecInspect.Lni.wa.gov</a></li> </ul>
